Dear Families, Dear Friends,



What is a Drug Pipeline?



Although Covid-19 is an infection that has forced half the global population to lockdown, the road to reaching a vaccine is long and the forecast for obtaining the final drug on the market is around 1 year or more. Some pharmaceutical companies are starting the road that will take them to the clinical trials of the vaccine.

What is it that takes so long to get a great new idea into the clinic to benefit patients sooner and faster than that?

What do we learn from Covid-19 that will be useful for gene therapy for BCM?

If you are hospitalized with Covid-19 symptoms please inform doctors that you are suffering from BCM. In fact use of chloroquine and hydroxychloroquine can cause retinal toxicity that mimics inherited retinal diseases. Be aware that a patient with BCM taking these drugs for COVID-19 would be very difficult to monitor for toxicity of the drug versus BCM effects.

"We do not know if these drugs can **accelerate** the visual loss in BCM, for example – that is unknown and would be a big concern. We may know some formula about how long and how much it takes to intoxicate the retina in those with normal vision but we have no idea what dose or how long it would take to worsen BCM retina."

"The risk of irreversible maculopathy at these higher doses for short periods of time is unknown. Patients should be informed of the potential for macular toxicity before starting therapy." <u>American Academy of Ophthalmology</u>





SARS-CoV2 Coronavirus and Gene Therapy Adeno-Associate Virus

Blue Cone Monochromacy Gene Therapy is based on Adeno-Associated Viruses (AAV) that will be modified to carry Opsin proteins inside the human retina and injected intravitreally in the eye... <u>read more</u>.

"AAV compared to the COVID19 Coronavirus, it is a simple comparison:

1) AAV and COVID19 are in no way biologically related to each other.

And most importantly, 2) AAV currently infects more than 80% of the world's population but causes no disease after 40 years of study. In stark contrast, after just a few months COVID19 has infected a small but growing fraction of many nations of the world and causes a terrible, often fatal, disease".

The Total Number of enrolled and validated patients is 30. We have more than 25 additional people who are waiting for their DNA test result or their clinician, to enroll.


The BCM Registry includes more United States and Canada residents than Europeans. So, Europeans, please: hurry up!
